Other Site Characteristics

The territory is a fragment of woodlands in the upper reaches of the river Dkhlovka. The significant part of the area (over 90%) is covered with forests: about 50% with coniferous forests including bog pine forests and about 50% with deciduous forests including broad-leaved. Bogs occupy about 5% of the territory. The territory lies in the basin divide between the basins of the river Mukhovets and the river Lesnaya.

4.2 Quality and importance

There are fragments of Quercus - Fraxinus - Carpinus betulus woodland (G1.A1), Enclave Picea abies forests (G3.1F), transition mires (D2.3) and other biotopes. The following species of mammals are found here: Canis lupus, Castor fiber; birds: Grus grus, Ciconia nigra, Dendrocopos medius, Dryocopus martius, Dendrocopos leucotos, Picoides tridactylus, Picus canus and others.
